TO: ALL HAWAII TOBACCO LICENSEES PURSUANT TO HAW. REV. STAT., CHAPTER 245
RE: NOTICE OF INJUNCTIONS PROHIBITING CERTAIN TOBACCO SALES

The Tobacco Enforcement Unit is writing to inform you that the following tobacco product manufacturers ("TPMs") have been found to be in violation of Haw. Rev. Stat., Chapters 486P and/or 675. As such, the TPMs listed below are prohibited from selling cigarettes or roll-your-own tobacco products ("RYO") to consumers within the State (whether directly or through a distributor, retailer or similar intermediary) for the time period as indicated.
