SCREENS:

- All screens:
 - o Dates to show lined up and consistent with leading zeros

- Juvenile Search Screen:
 - o Display how many found from search
 - o Help Tab- list/explain acronyms and abbreviations
 - o Add Ethnicity in hover(mouse over) display
 - o Show Verified Flag for verified Information
 - o Show a flag when APBs are cancelled or served
 - (RMS/Denalli needs to send it) *wait for HCPD to check
 - o Show fingerprint date and agency in Offense block
 - o Show photograph date and agency in Offense block
 - o Add Division and/or Agency in Photo Section
 - o Add Cell and Home Phone for Associated Persons
 - o Change "Date Entered" to "Last Updated" in Juv Home Address block
 - o Change "Juv Home Addresses" to "Juv Addresses"

- Question: Are court programs from Justice?
- Can a field show the youth sent or returned to 3rd circuit from the correctional facility?

- Family Court Letters of Apprehension Screen:
 - Show FCJ# as well as JJIS #
- Add Missing/Wanted Screen:
 - Add dropdown to select type for "Reported By" tab
 - "Reported By" and "Caller"
 - Have ability to add multiple types
 - Add Checkbox for Maile Alert activated
 - Place on right side, on JJIS ID line, in Red
