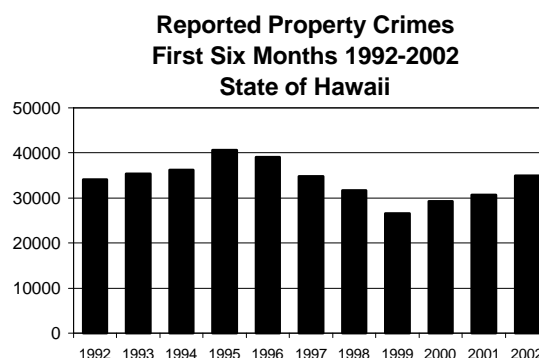
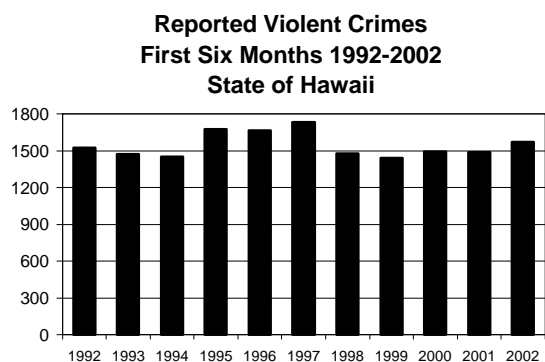
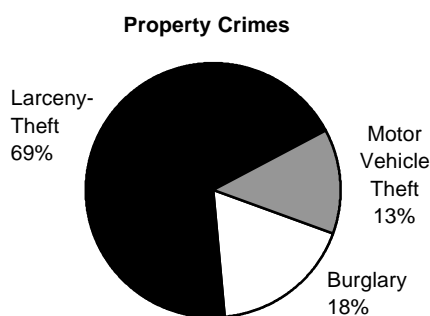
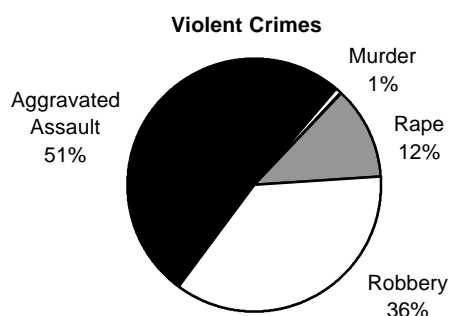

Data derived from arrests and crimes reported to the police can only provide estimates of the actual extent of crime. Shifts in law enforcement focus, isolated cases resulting in multiple arrests, and broader societal changes that affect the likelihood that victims will report certain types of crimes are some of the factors that may affect these data.

The number of Index Crimes¹ reported in Hawaii during the first six months of 2002 increased 13.3% from the number reported during the same period in 2001. The number of reported violent crimes (murder, forcible rape, robbery, and aggravated assault) increased 5.4%, and the number of reported property crimes (burglary, larceny-theft, and motor vehicle theft) rose 13.7%.

The City & County of Honolulu, Hawaii County, and Kauai County each posted increases in total Index Crimes; Maui County posted a 5.0% decrease. For violent crimes, the City & County of Honolulu and Kauai County posted increases of 7.5% and 71.7%, respectively, while Hawaii County reported a 21.8% decrease and Maui County a drop of 6.1%. Maui County posted the only decrease in reported property Index Crimes, down 5.0%.

Juvenile arrests for Index and Part II offenses increased 1.4% and adult arrests rose 5.0% during the first six months of 2002. There was a 50.4% increase in juvenile arrests for violent Index Crimes and a 4.8% drop for property Index Crimes. Adult arrests for violent and property Index Crimes increased 16.8% and 0.7%, respectively. The proportion of Index Crimes cleared by arrest or exceptional means (16.7%) increased by 4.2 percentage points.

The value of property stolen in Hawaii during the first half of 2002 totaled \$32.2 million, up 6.5% from the same period in 2001.

¹ Index Crimes include murder, forcible rape, robbery, aggravated assault, burglary, larceny-theft, and motor vehicle theft.
