**CEASE AND DESIST ORDER**


AND NOW, THIS 28th DAY OF AUGUST 2014, THE ATTORNEY GENERAL, STATE OF HAWAII, HAVING FOUND THAT **HAWAII VA FOUNDATION** OR ITS AGENTS, EMPLOYEES OR AUTHORIZED REPRESENTATIVES, HAS OR HAVE DIRECTLY, OR INDIRECTLY, SOLICITED CONTRIBUTIONS IN THE STATE OF HAWAII FOR CHARITABLE, CIVIC, PATRIOTIC OR BENEVOLENT PURPOSES WHILE IT IS NOT REGISTERED AS A CHARITABLE ORGANIZATION PURSUANT TO SECTION 467B-2.1, HAWAII REVISED STATUTES ("HRS"), AND HAS COMMITTED PROHIBITED PRACTICES DESCRIBED BY SECTIONS, 467B-9 (h), (i) AND (j), HRS; IN ACCORDANCE WITH SECTIONS 467-9.7(a), AND 467B-17, HRS. THE ATTORNEY GENERAL HEREBY ORDERS **HAWAII VA FOUNDATION**, OR ITS AGENTS, EMPLOYEES OR AUTHORIZED REPRESENTATIVES TO CEASE AND DESIST FROM DIRECTLY OR INDIRECTLY SOLICITING CONTRIBUTIONS IN HAWAII FOR ANY CHARITABLE PURPOSE UNTIL

SUCH TIME AS IT RESPONDS TO THE ATTORNEY GENERAL AND DULY REGISTERS OR APPLIES FOR AND RECEIVES AN EXEMPTION FROM REGISTRATION UNDER SECTION 467B-11.5, HRS.

ADDITIONALLY, PURSUANT TO SECTION 467b-9.7(b), HRS, **HAWAII VA FOUNDATION**, OR ITS AGENTS, EMPLOYEES OR AUTHORIZED REPRESENTATIVES MAY BE SUBJECT TO AN ADMINISTRATIVE PENALTY OF \$1000 AND AN ADDITIONAL PENALTY OF \$100 PER DAY FOR EACH DAY THE VIOLATION CONTINUES.

**THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.**
