

CEASE AND DESIST ORDER

AND NOW, THIS 21ST DAY OF FEBRUARY 2012, THE ATTORNEY GENERAL, STATE OF HAWAII, HAVING FOUND THAT UNLIMITED RESOURCES GIVING ENLIGHTENMENT, AKA, U.R.G.E. INC., 60 EAST 42ND STREET, SUITE 1442, NEW YORK, NY 10165 (URGE), THOMPSON'S PRODUCTIONS, LLC., 3410 DE REIMER AVENUE, SUITE 12F, BRONX, NY 10475 (THOMPSON'S), TANTRIQ ENTERTAINMENT, LLC., 2916 DATE STREET, SUITE 16D, HONOLULU, HI 96816 (TANTRIQ), ZIGGY MARLEY MANAGEMENT, 8391 BEVERLY BLVD., SUITE 124, LOS

CEASE & DESIST ORDER

ANGELES, CA 90048 (ZMM), AND HAWAII PACIFIC ENTERTAINMENT, LLC (D.B.A.HPE LIVE), 1221 KAPIOLANI BLVD., SUITE 6A-1, HONOLULU, HI 96814 (HPE) ARE NOT REGISTERED AS A CHARITABLE ORGANIZATION WITH AND/OR HAVE NOT SUBMITTED A COMMERCIAL COVENTURER AGREEMENT TO THE STATE OF HAWAII, DEPARTMENT OF THE ATTORNEY GENERAL, AS REQUIRED BY SECTIONS 467B-2.1, AND 467B-5.5, HAWAII REVISED STATUTES (HRS), AND HAVE DIRECTLY OR INDIRECTLY SOLICITED CONTRIBUTIONS IN THE STATE OF HAWAII WHILE NOT BEING REGISTERED AND NOT HAVING SUBMITTED A COMMERCIAL COVENTURER AGREEMENT; IN ACCORDANCE WITH SECTION 467B-9.7(b)(2), HRS, THE ATTORNEY GENERAL HEREBY ORDERS **URGE, THOMPSON'S, TANTRIQ, ZMM, AND HPE**, TO CEASE AND DESIST FROM SOLICITING CONTRIBUTIONS IN HAWAII UNTIL SUCH TIME AS **URGE, THOMPSON'S, TANTRIQ, ZMM, AND HPE**, RESPOND TO THE ATTORNEY GENERAL AND DULY REGISTER AND SUBMIT A COMMERCIAL COVENTURER AGREEMENT OR PROVIDE INFORMATION THAT THEY ARE EXCLUDED OR EXEMPT FROM REGISTRATION.

ADDITIONALLY, PURSUANT TO HRS CHAPTER 467B, **URGE, THOMPSON'S, TANTRIQ, ZMM, AND HPE** MAY BE SUBJECT TO AN ADMINISTRATIVE PENALTY OF \$1000 AND AN ADDITIONAL PENALTY OF \$100 PER DAY FOR EACH DAY THE VIOLATIONS CONTINUE.

ADDITIONALLY, HAVING FOUND THAT ON JUNE 9, 2011, THE INTERNAL REVENUE SERVICE POSTED PUBLIC NOTICE OF THE AUTOMATIC REVOCATON OF **URGE'S** 501(c)(3) TAX EXEMPT STATUS AND AS OF THE DATE OF THIS ORDER, THE INTERNAL REVENUE SERVICE HAS NOT REINSTATED **URGE'S** TAX EXEMPT STATUS, AND THAT THE ZIGGY MARELY WEBSITE, [HTTP://WWW.ZIGGYMARLEY.COM/URGE-RESOURCES.PHP](http://www.ziggymarley.com/urge-resources.php) CURRENTLY ALLOWS THE PUBLIC TO MAKE DONATIONS TO **URGE** AND CONTAINS THE STATEMENT, "U.R.G.E. IS REGISTERED WITH THE INTERNAL REVENUE SERVICE AS A NONPROFIT, TAX EXEMPT 501(c)(3) ORGANIZATION," THE ATTORNEY GENERAL

HEREBY ORDERS **URGE** TO CEASE AND DESIST FROM MAKING FALSE, DECEPTIVE OR MISLEADING STATEMENTS IN THE SOLICITATION OF CONTRIBUTIONS IN VIOLATION OF SECTION 467B-9(k), HRS.

ADDITIONALLY, PURSUANT TO SECTIONS 467B-9(k), AND 467B-9.7, HRS, **URGE** MAY BE SUBJECT TO AN ADMINISTRATIVE PENALTY OF \$1000 AND AN ADDITIONAL PENALTY OF \$100 PER DAY FOR EACH DAY THE VIOLATION CONTINUES AND MAY BE SUBJECT TO A CIVIL PENALTY PURSUANT TO SECTIONS 467B-10.5, 480-2, AND 480-3.1, HRS, OF NOT LESS THAN \$500 NOR MORE THAN \$10,000 FOR EACH VIOLATION AND FOR EACH DAY THE VIOLATION CONTINUES.

THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
