TO: ALL HAWAI'I TOBACCO LICENSEES PURSUANT TO HAW. REV. STAT., CHAPTER 245

RE: **NOTICE OF INJUNCTIONS PROHIBITING TOBACCO SALES**

We are writing to inform you that the following tobacco product manufacturers have been found to be in violation of Haw. Rev. Stat., Chapter 486P or 675. As such, the tobacco product manufacturers listed below are prohibited from selling cigarettes or roll-your-own tobacco products ("RYO") to consumers within the State (whether directly or through a distributor, retailer or similar intermediary) for the period indicated below.
