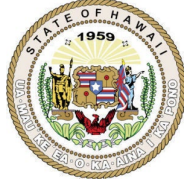

RE: Update from FDA regarding additional authorized tobacco products

Dear Tobacco Retailer:

The purpose of this letter is to inform State of Hawaii tobacco retailers and licensees of a recent announcement by the U.S. Food and Drug Administration (“FDA”).

On May 5, 2026, the FDA announced the new authorization of marketing of four additional e-cigarette products to be sold in the United States. The products for which the FDA issued marketing granted orders are the following:

- GOLD 50 MG/ML Pod
- SAPPHIRE 50 MG/ML Pod
- FRESH MENTHOL 50 MG/ML Pod
- CLASSIC MENTHOL 50 MG/ML Pod

The four newly authorized e-cigarette products are manufactured by Glas Inc. To date, only six Glas Inc. products in total have received authorization, and that authorization does not extend to any other Glas Inc. products.

The FDA further stated in the announcement: “There is no safe tobacco product. Those who do not currently use tobacco products should not start. Youth should never use tobacco products.”

To date, only 45 e-cigarettes and 26 nicotine pouches have been authorized by the FDA to be sold in the United States. Enclosed is the updated flyer of “E-Cigarettes Authorized by the FDA.”

The Department asks that you remove from your shelves any products not authorized for sale and return them to their distributor or manufacturer, keeping in mind that these products may be considered hazardous materials.
