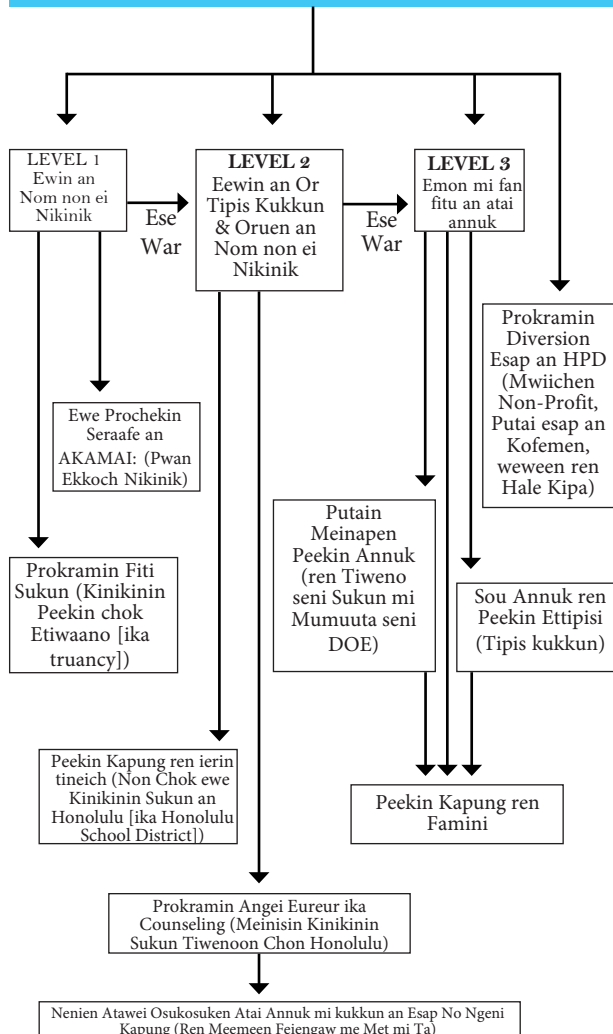
Ekkoch Prokramen Kukun

Ew Flow Chart ren Criminal Justice (Pekin Annukun Kapwung)

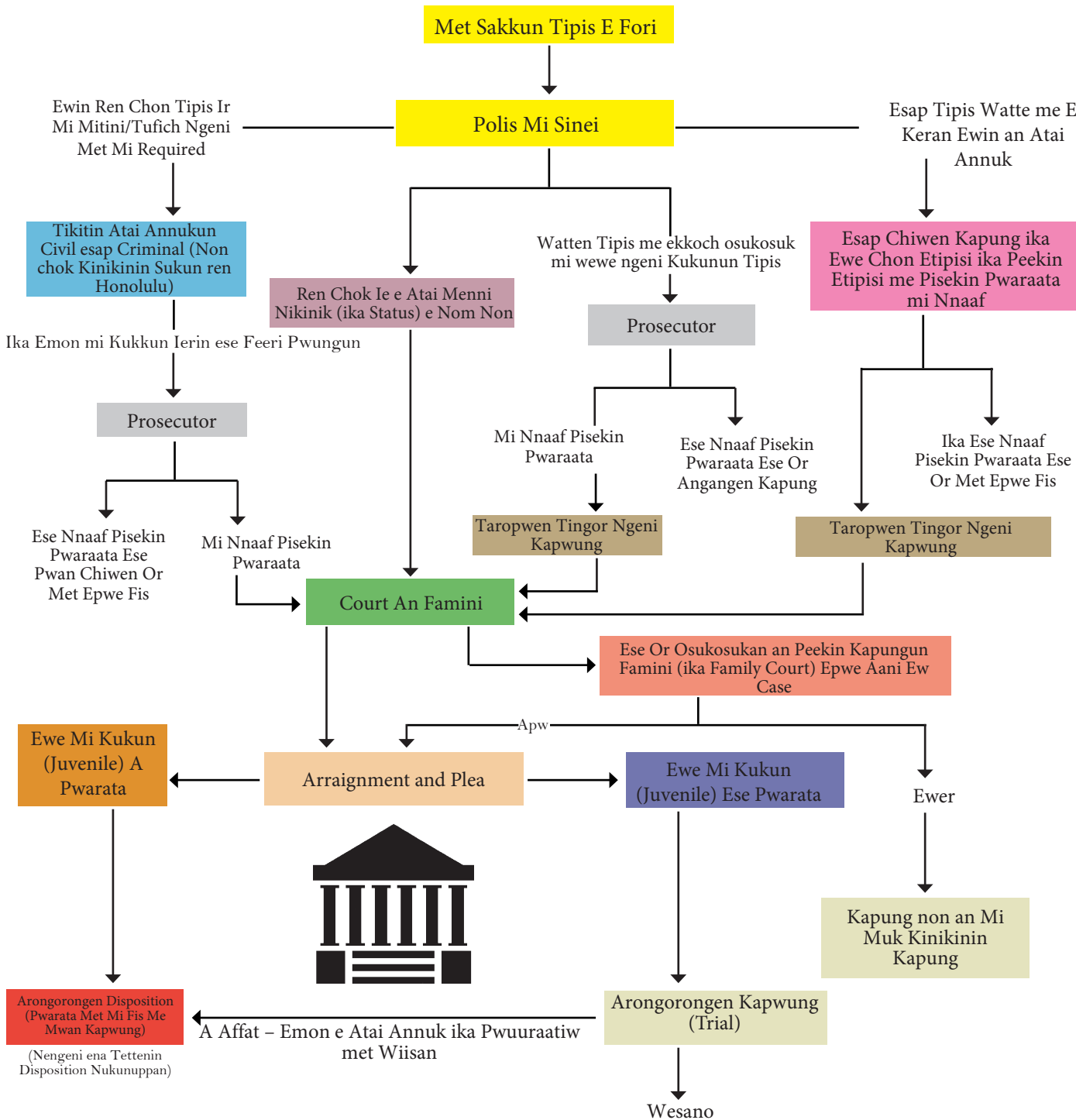

Arongoron Kapwung: Ew mwichen kapwung epwe usun ew trial fanitan watte; epwe tongeni sinei ika i (ewe kukun) a men tipis ika esapw.

Ewe Prochekin Seraafe an AKAMAI: Ew prochekin non kaminiti choochon e ffeer seni ewe Putain Ponis an Honolulu (ika Honolulu Police Department [HPD]), ewe Ofesin Peekin Anisi Seraafe (ika Office of Youth Services), me ekkoch putai non kofemen, ekkoch mwicheich (ika private groups), chon fanantier me chon fiti ei angangen anisi sam me iin me neur seraafe mi nom non manawen osukosuk.

Kapwungun Ateten: Ew arongoron fanitan ewe aureuran ewe kukun (juvenile) fanitan ekkewe atatur ren an atai annuk, pwan aureuran ren an kewe pwung (constitutional rights) me uwau mefian an epwe “enter ew plea” ika fiti ew atipeew an epwe koturitiw tipis.

Wesano: A wewe ngeni emon watte e “found not guilty” ika ese tipis/fangeta.

Disposition (Pwarata Met Mi Fis Me Mwan Kapwung): Wewe ngeni ew pwungun kapwung non an watte court. Ewe court a afata met niwiningaw epwe ngeni emon kukun (juvenile) mi fen finata ika mi fen pwarata pwe i a men fori ew tipis (katon ewe list’en disposition nesokuran ei taropwe).

Watten Tipis: Ew tipis ika foforongaw mi konien tichik seni ew kukunun tipis (misdemeanor) nge mi pwan weires angangen.

Kesiwinin Mwokutukutun Ewe Keis Me Nukun Court: Ew non-judicial (ese fis non court), administrative (ren ekkoch chon angangen kapwung), disposition (met epwe fis me mwan kapwung) ren ew referral, ikewe ewe mi kukun (juvenile) me saman/iinan ra tipeew ngeni ekkewe annuk (terms), esapw wor arongoron.

Kukunun Tipis (Misdemeanor): Ew tipis/foforongaw mi chok kukun angangen seni ew watten tipis (felony) nge mei watte seni ew “petty” (kukunun) misdemeanor ew “fine” (niwinin ika meen kapwung) kopwe menatiw.

Taropwen Tingor Ngeni Kapwung: Echo taropwen annuk mi fael non ewe Court An Famini fanitan ew tipis (atai annuk ika atai aureur/napanap) mi for ren emon mi kukun (juvenile).

Plea/Atipeew: Ponuwan kapas eis seni ewe mi kukun (juvenile) ren ew taropwen tingor ngeni kapwung (pwarata ika ese pwarata).

Prosecutor: Noun mwuun lawyer ika attorney ewe mi kefinita an epwe wisen fori angangen ewe taropwen tingor ngeni kapwung (petition) fanitan ewe mi kukun (juvenile).

Prokramin Fiti Sukun (ika School Attendance Program [SAP]): Prokran ren chon sukun re pwa ren ponis ar rese fiti sukun.

Ekkewe Mi Atai Aureur/Napanap: Emon aramas mi ierir 18 feitiw, mi fori ekkei fofor ren tou (rikino) seni sukun, suno, ika weires nonomun.

Court An Serafo/Teen: Ew prokran fanitan anisin chon sukun ekkewe re keran ewin ares ar resapw chiwen ares mwach kan ren ar atai annuk, ina pwata anis fanitan akukunano foforongawan serafo/teen. Chon sukun ir mi pwarata ar tipis ir repwe no ngeni kapwung ren jury ika ekkoch chon sukun, anis seni ekkewe volunteers seni chon middle me high sukun, attorneys ika lawyers, me ekkoch agency an community.
