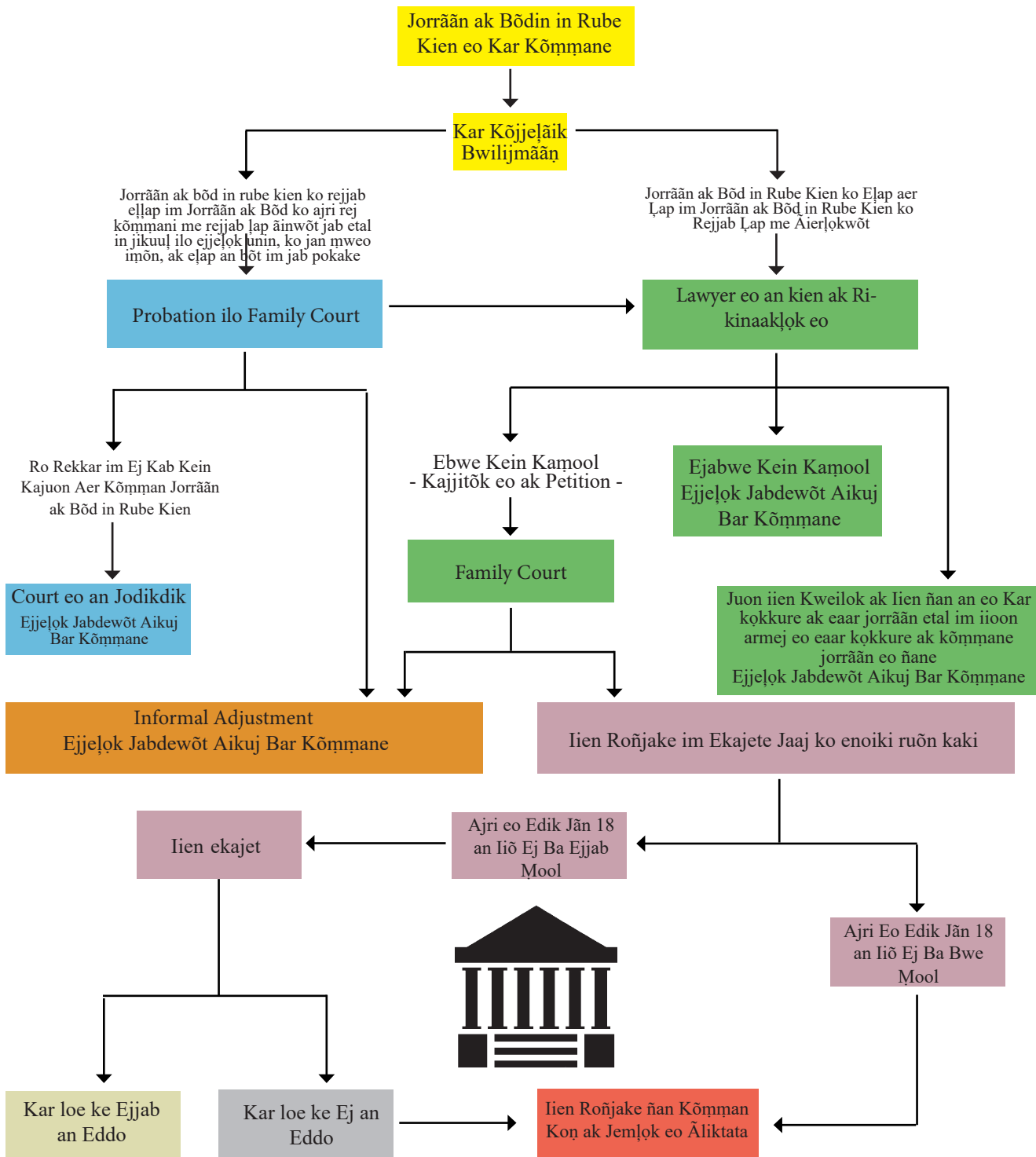

Iien Roņjake eo nān Kwaļok ak Kōmmane juon jemļok ak alikkar: Ejja āinwōt iien ekajet eo an ro rerūtto; ej peke im kalikkar eļāñne ajri eo edik jān 18 an iio eaar ak eaar jab kōmmane jorrāān eo ak bōd in rube kien eo enoik ruōn kake

Arraignment: Iien roņjake eo me rej leļok naan in kapilok nān ajri eo edik jān 18 an iio ikijeen jaaj ko ak jorrāān ak bōdin rube kien ko enoiki ruōn kaki, kōkapiloklōke kōn jimwe im maroñ ko an iumwin jemān āe eo im leļok nāne iien nān an kwaļok uwaak eo an ñe ebōd ak ejjab bōd. Eļāñne ajri eo edik jān 18 an iio enaaj uwaak bwe ejjab bōd, innem naaj karōk iien roņjake case eo (i.e. iien ekajet).

Joļoke case eo nae juon armej eo emōj kar enoik ruōn kōn jorrāān ak bōd in rube kien: Ejja āinwōt ñe rej lo an ejjelok ruōn juon eo erūtto.

Koņ ak jemļok eo āliktata: Ejja āinwōt jemļok eo ikijeen kaje eo ilo court eo an ro rerūtto. Jorrāān ak bōd in rube kien eļap: Juon jorrāān ak bōd in rube kien eo watōke bwe eļap an Ẅap jān juon jorrāān ak bōd in rube kien ejjap Ẅap im enanaļok kaje ko nāne.
