Written and Oral Testimony:

Interested persons can submit written testimony in advance of each meeting that will be distributed to Commission Members prior to the meeting. **It is recommended that written testimony be submitted no later than 24 hours prior to the meeting** to ensure time for Commission Members to review it. All written testimony will be considered and retained as part of the record, but we cannot assure Commission Members will receive it with sufficient time for review prior to decision-making. To provide live oral/video testimony during the online meeting, it is recommended that you email your request to gvvcc@hawaii.gov at least 24 hours in advance, with your name, phone number, email address, and the agenda item on which you would like to testify. You will receive an email with the Zoom link or phone number via which

to testify. You will need a computer with internet access, video camera, and microphone to participate. If you require access by phone only, please indicate that in your email request. Testimony will be limited to a maximum of three (3) minutes per person per agenda item.

IN-PERSON ACCESS:

Interested persons can attend (access by audiovisual connection) the ZOOM meeting at the Leiopapa A. Kamehameha building, 235 S. Beretania Street, 15th Floor (corner of Beretania Street and Alakea Street, across St. Andrew's Priory). A valid government issued identification is required to enter the building.

INTERNET ACCESS:

To view the meeting and provide live oral testimony, please use the Zoom link above. You will be asked to enter your name. The Commission requests that you enter your full name, but you may use a pseudonym or other identifier if you wish to remain anonymous. You will also be asked for an email address.

Your microphone will be automatically muted. When the Chairperson asks for public testimony, you may click the Raise Hand button found on your Zoom screen to indicate that you wish to testify about that agenda item. The Chairperson will individually enable each testifier to unmute their microphone. When recognized by the Chairperson, please unmute your microphone before speaking and mute your microphone after you finish speaking.

PHONE ACCESS:

If you cannot get internet access, you may get audio-only access by calling the phone number listed above. Upon dialing the number, you will be prompted to enter the Webinar ID which is also listed above. After entering the Webinar ID, you will be asked to either enter your panelist number or wait to be admitted into the meeting. If you are a member of the public, you will not have a panelist number. So, please wait until you are admitted into the meeting.

When the Chairperson asks for public testimony, you may indicate you want to testify by entering * and then 9 on your phone's keypad. After entering * and then 9, a voice prompt will let you know that the host of the meeting has been notified. When recognized by the Chairperson, you may unmute yourself by pressing * and then 6 on your phone. A voice prompt will let you know that you are unmuted. Once you are finished speaking, please enter * and then 6 to mute yourself.

For both internet and phone access, when testifying, you will be asked to identify yourself and the organization, if any, that you represent. Each testifier will be limited to three minutes of testimony per agenda item.
