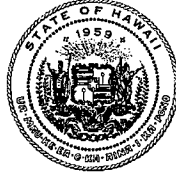


IN THE MATTER OF: AD SOLUTIONS HAWAII, LLC

CEASE AND DESIST ORDER

AND NOW, THIS 25th DAY OF APRIL 2014, THE ATTORNEY GENERAL, STATE OF HAWAII, HAVING FOUND THAT **AD SOLUTIONS, HAWAII, LLC**, ("RESPONDENT") OR ITS AGENTS, EMPLOYEES OR AUTHORIZED REPRESENTATIVES, HAS OR HAVE DIRECTLY, OR INDIRECTLY, SOLICITED CONTRIBUTIONS IN THE STATE OF HAWAII FOR CHARITABLE, CIVIC, PATRIOTIC OR BENEVOLENT PURPOSES WHILE ACTING AS A PROFESSIONAL SOLICITOR, AND THAT RESPONDENT IS NOT REGISTERED AS A PROFESSIONAL SOLICITOR PURSUANT TO SECTION 467B-12 AND HAS COMMITTED PROHIBITED PRACTICES DESCRIBED BY SECTIONS 467B-2.5(c) and 467B-12, 467b-9(d), (h) and (j), HAWAII REVISED STATUTES; IN ACCORDANCE WITH SECTION 467-9.7(a), HAWAII REVISED STATUTES, THE ATTORNEY GENERAL HEREBY ORDERS **RESPONDENT**, OR ITS AGENTS, EMPLOYEES OR AUTHORIZED REPRESENTATIVES TO CEASE AND DESIST FROM DIRECTLY OR INDIRECTLY SOLICITING CONTRIBUTIONS IN HAWAII FOR ANY CHARITABLE PURPOSE UNTIL SUCH TIME AS IT RESPONDS TO THE ATTORNEY GENERAL AND DULY REGISTERS. ADDITIONALLY **RESPONDENT**, OR ITS AGENTS, EMPLOYEES OR AUTHORIZED REPRESENTATIVES ARE ORDERED TO CEASE AND DESIST FROM MAKING FALSE, DECEPTIVE OR MISLEADING STATEMENTS IN THE SOLICITATION OF CONTRIBUTIONS, INCLUDING BUT NOT LIMITED TO MAKING ANY REPRESENTATION THAT WOULD LEAD A REASONABLE DONOR OR CONSUMER TO BELIEVE THAT DONATIONS, PURCHASES OR CONTRIBUTIONS ARE TAX DEDUCTIBLE.

ADDITIONALLY, **RESPONDENT**, OR ITS AGENTS, EMPLOYEES OR AUTHORIZED REPRESENTATIVES MAY BE SUBJECT TO AN ADMINISTRATIVE PENALTY OF \$1000 AND AN ADDITIONAL PENALTY OF \$100 PER DAY FOR EACH DAY THE VIOLATION CONTINUES. THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.
