ASSURANCE OF VOLUNTARY  
DISCONTINUANCE

WHEREAS, Russell Suzuki, Attorney General of the State of Hawaii, pursuant to his authority under sections 467B-9.3 and section 28-2.5, Hawaii Revised Statutes, has conducted an investigation into certain practices of MJ888M Productions, Inc.;

WHEREAS, MJ888M Productions, Inc., is a domestic for-profit corporation domiciled in Hawaii;

WHEREAS, MJ888M Productions, Inc. is a professional solicitor, as defined in section 467B-1, Hawaii Revised Statutes, that solicit contributions in the State of Hawaii for the Hawaii Police Athletic Federation as an independent contractor for Hawaii Law Enforcement Publication ("HELP");

WHEREAS, HELP is also a registered professional solicitor in the State of Hawaii;

WHEREAS, the Attorney General accepts this Assurance of Voluntary Discontinuance by MJ888M Productions, Inc. and HLEP pursuant to section 467B-9.3(d), Hawaii Revised Statutes;

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, without a hearing and without any formal admission by donor MJ888M Productions, Inc. and HELP of any violation of law, among Russell Suzuki Attorney General, State of Hawaii, by Hugh R. Jones, Supervising Deputy Attorney General, and J888M Productions, Inc. and HLEP (the "Parties") as follows:

1. The Parties agree to a 60 day suspension of Productions and HLEP from any solicitation activity effective on February 23, 2015.
2. Productions and HLEP jointly pay \$887.00 the cost incurred in paying Honolulu Reporting service for the court reporting services during this investigation within 10 days after the execution of this AVD.
3. Productions and HLEP jointly pay a civil penalty of \$10,000 in monthly installments of \$2000.00 per month for five consecutive months; payments to commence upon the expiration of

the 60 day suspension period provided for in paragraph 1 above. In the event of a missed installment payment the AVD will be rescinded and be null and void.

4. Productions and HLEP agree to disclose to potential donors at the outset of any solicitation phone call that they are a paid solicitor for any charity they are soliciting on behalf of.
5. Productions will cease soliciting gifts in kind for any charitable organization.
6. Productions and HLEP agree to modify its telemarketing scripts in a manner that prevents donor confusion. Any and telemarketing scripts shall be subject to review and approval of the Attorney General.
7. Productions and HLEP will timely file end of solicitation campaign financial reports to the extent required by Hawaii law.
8. Productions and HLEP's contracts will comply with section 467B-12.5, HRS.
9. Productions will comply with section 387-6(c), HRS.
10. Productions will supply a copy of the AVD to the Hawaii Police Athletic Federation.
11. The failure to abide by the terms of the AVD shall by consent of Productions and HLEP in the AVD, will subject Productions and HLEP to a complete prohibition on solicitation for any charitable organization for a period of one (1) year if proven to the satisfaction of a court having competent jurisdiction in the State of Hawaii.

This Assurance shall be binding on MJ888M Productions, Inc. and HLEP and its successors and assigns, employees, agents, corporate successors and another individual through whom it acts.


This assurance shall constitute the entire agreement between the Parties hereto. This Assurance cannot be changed or modified except in a writing duly executed by the parties hereto.

The person signing this Assurance on behalf of MJ888M Productions, Inc. and HLEP represents that he or she is authorized to sign it on behalf of their corporations.

It is further understood and agreed that the acceptance of this Assurance by the Attorney General shall not be deemed or construed as approval by the Attorney General of any activities of MJ888M Productions, Inc. and HLEP they shall not make any representation to the contrary.

This AVD may be executed in counterparts.
