**IN THE MATTER OF: HAWAII RUSH SOCCER CLUB**  
**CEASE AND DESIST ORDER**

AND NOW, THIS 4TH DAY OF JUNE 2014, THE ATTORNEY GENERAL, STATE OF HAWAII, HAVING FOUND THAT **HAWAII RUSH SOCCER CLUB**, OR ITS AGENTS, EMPLOYEES OR AUTHORIZED REPRESENTATIVES, HAS OR HAVE DIRECTLY, OR INDIRECTLY, SOLICITED CONTRIBUTIONS IN THE STATE OF HAWAII FOR CHARITABLE, CIVIC, PATRIOTIC OR BENEVOLENT PURPOSES WHILE IT IS NOT REGISTERED AS REQUIRED BY SECTION 467B-2.1, HAWAII REVISED STATUTES ("HRS") AND HAS COMMITTED PROHIBITED PRACTICES DESCRIBED BY SECTION 467B-9 (h), (i), AND (j) HRS; IN ACCORDANCE WITH SECTIONS 467B-9.7(a) and 467B-17, HRS, THE ATTORNEY GENERAL HEREBY ORDERS **HAWAII RUSH SOCCER CLUB**, ITS AGENTS, EMPLOYEES OR AUTHORIZED REPRESENTATIVES, TO IMMEDIATELY CEASE AND DESIST FROM DIRECTLY OR INDIRECTLY SOLICITING CONTRIBUTIONS IN HAWAII FOR ANY CHARITABLE PURPOSE UNTIL SUCH TIME AS IT RESPONDS TO THE ATTORNEY GENERAL AND DULY REGISTERS. ADDITIONALLY, PURSUANT TO SECTION 9.7(b), **HAWAII RUSH SOCCER CLUB**, OR ITS AGENTS, EMPLOYEES OR AUTHORIZED REPRESENTATIVES MAY BE SUBJECT TO AN ADMINISTRATIVE

PENALTY OF \$1000 AND AN ADDITIONAL PENALTY OF \$100 PER DAY FOR EACH DAY THE VIOLATION CONTINUES. **THIS ORDER SHALL TAKE EFFECT IMMEDIATELY.**
