**INMATE CHARGED WITH ASSAULT OF ADULT  
CORRECTIONS OFFICER AT WOMEN'S CORRECTIONAL FACILITY**

HONOLULU – Attorney General Doug Chin announced that inmate Alex Parks was charged today with assault in the second degree and harassment against adult corrections officers at the Women's Community Correctional Center.

Assault in the second degree is a class C felony and carries a maximum sentence of 5 years in prison and a \$10,000.00 fine. Harassment is a petty-misdemeanor and carries a maximum sentence of 30 days in jail and a \$1,000.00 fine.

Alex Parks is presumed innocent unless and until she is found guilty of the charges beyond a reasonable doubt. A copy of the charging document is attached.

**FELONY INFORMATION & NON-FELONY COMPLAINT**

The Department of the Attorney General charges:

COUNT I: On or about the 30<sup>th</sup> day of June, 2017, in the City and County of Honolulu, State of Hawaii, ALEX PARKS did intentionally or knowingly cause bodily injury to Michelle Halemano, a correctional worker, as defined in Section 710-1031(2) of the Hawaii Revised Statutes, who was engaged in the performance of duty or who was within the Women’s Community Correctional Center, a correctional facility, thereby committing the offense of

Assault in the Second Degree, in violation of Section 707-711(1)(c) of the Hawaii Revised Statutes.

“Bodily injury” means physical pain, illness, or any impairment of physical condition.

“Correctional worker”, as used in this section means any employee of the State or any county who works in a correctional or detention facility, a court, a paroling authority or who by law has jurisdiction over any legally committed offender or any person placed on probation or parole.

COUNT II: On or about the 30<sup>th</sup> day of June, 2017, in the County of Honolulu, State of Hawaii, ALEX PARKS, with intent to harass, annoy, or alarm another person, to wit: Michelle Halemano and/or Tyler Len, did strike, shove, kick, or otherwise touch Michelle Halemano and/or Tyler Len in an offensive manner or subject Michelle Halemano and/or Tyler Len to offensive physical contact, thereby committing the offense of Harassment in violation of Section 711-1106 (1)(a) of the Hawaii Revised Statutes.
