ASSAULT CHARGES FILED

HONOLULU – Oahu resident Shaun Dydasco was charged today with two counts of Assault in the Third Degree.

According to the Amended Complaint, Dydasco allegedly assaulted Roy Kalama on two separate occasions on April 28, 2017.

Assault in the Third Degree is a misdemeanor with a maximum sentence of one year in jail and a \$2,000.00 fine.

Dydasco is presumed innocent unless and until he is found guilty of the charges beyond a reasonable doubt.
