#### **Summary of Duties:**

The Public Safety, Hawaiian Home Lands and Housing Division (PSHHD) provides legal services to a variety of State departments and agencies including the Department of Public Safety, the Department of Hawaiian Homelands, the Hawaii Housing Finance and Development Corporation, the Hawaii Public Housing Authority, and the Hawaii Community Development Corporation.

This position is responsible for legal representation of the Department of Hawaiian Home Lands (DHHL). This deputy attorney general position provides a variety of legal services including but not limited to advice and counsel and document review (contracts, development agreements, finance agreements, leases, transfers, etc.) litigation on issues involving numerous aspects of the Hawaiian Homes Commission Act and its programs, legislation, and other legal services as needed.

#### **Minimum Requirements:**

- Education/Experience: Graduate from an accredited law school.
- Knowledge/Ability: Knowledge of applicable State and Federal laws, rules, regulations and computer
  applications/software. Awareness of both Federal District and State Court of Rules of civil and criminal
  procedure, including Local Rules of Federal District Court and State Circuit Court Rules.

Ability to perform legal research, analyze, manage, produce and organize documents as needed, understand and apply administrative rules and court rules; give and receive oral and written instructions; use computer. Appropriate and current legal writing skills, including the ability to write logically and persuasively. Ability to set personal and professional example; leadership, supervisory or administrative ability or knowledge; strong organizational skills; good communication skills.

 License/Certificate: Active Hawaii State Bar License to practice law in all courts of the State of Hawaii and the United States District Court for the District of Hawaii.
