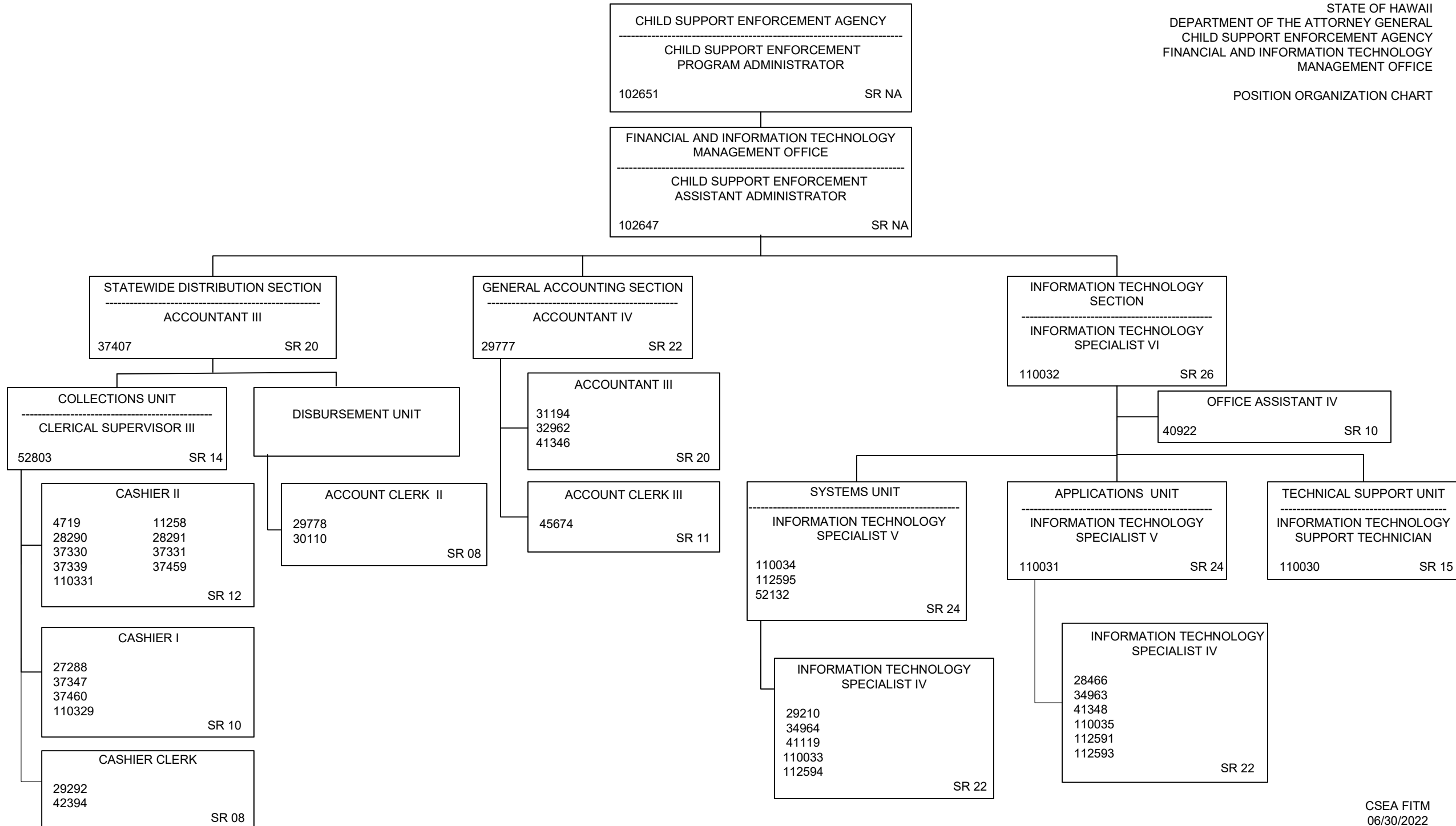
POSITION ORGANIZATION CHART



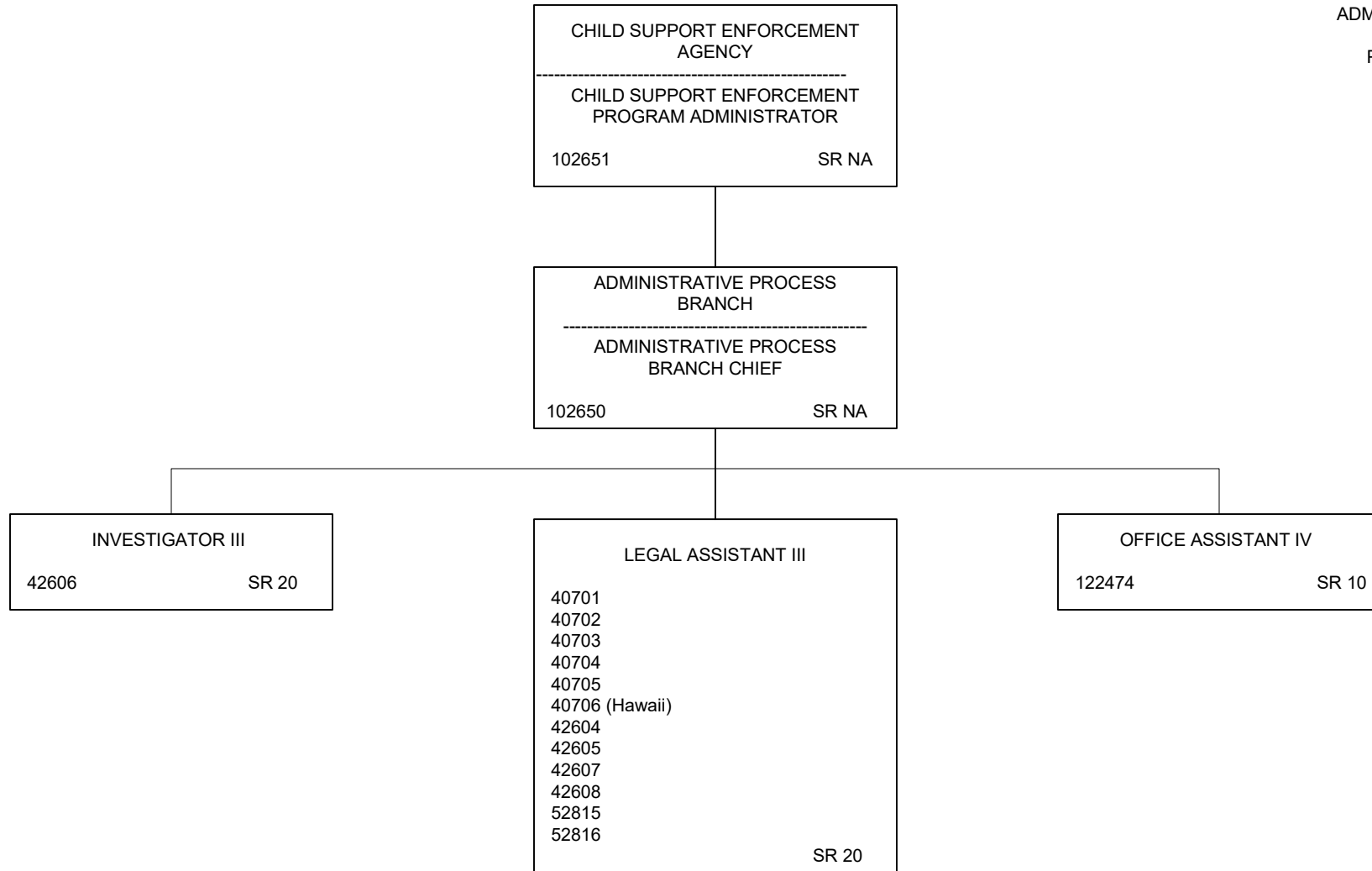
