**ATTORNEY GENERAL LOPEZ URGES PUBLIC TO REGISTER FOR  
NOTIFICATIONS ON FILING CLAIMS FOR COMPENSATION IN  
GENERIC DRUG SETTLEMENTS**

HONOLULU — Attorney General Anne Lopez today alerted Hawai'i consumers who purchased generic drugs between May 1, 2009 and December 31, 2019, that they may be eligible to receive compensation.

Recently, the presiding court approved a settlement reached with generic drug manufacturer Apotex Corp. ("Apotex Settlement") which settles certain claims asserted in antitrust and consumer protection lawsuits currently pending in the United States District Court for the District of Connecticut (the "States' Actions"), and the United States District Court for the Eastern District of Pennsylvania (the "EPP Class Actions").

The Apotex settlement stems from litigation alleging that certain generic drug manufacturers engaged in widespread, long-running conspiracies to artificially inflate and manipulate drug prices, reduce competition, and unreasonably restrain trade with regard to numerous generic prescription drugs.

Since further settlements may be forthcoming, a final complete list of generic drugs has not been established, nor has the court approved a final distribution plan. Registration will ensure that Hawai'i consumers who register will be notified of future settlements and the claims filing process.
